AN ACT

Amending the act of June 30, 1987 (P.L.163, No.16), entitled "An act providing for the revitalization of rural Pennsylvania; 2 establishing the Center for Rural Pennsylvania; providing for 3 rural education partnerships and adult literacy programs; 4 allocating funds appropriated to the Department of Commerce 5 for a Regional Center for Continuing Education of Health 6 Science Practitioners in western Pennsylvania; making 7 appropriations; and making a repeal," in Center for Rural Pennsylvania, further providing for board of directors; and 9 making a repeal. 10 11 The General Assembly of the Commonwealth of Pennsylvania 12 hereby enacts as follows: 13 Section 1. Section 302(a) of the act of June 30, 1987 (P.L.163, No.16), known as the Rural Pennsylvania Revitalization 14 15 Act, is amended to read: 16 Section 302. Board of directors. Members. -- The Center for Rural Pennsylvania shall be 17 18 governed by a board of directors which shall consist of [11] 19 members.] members appointed as follows: 20 The Speaker of the House of Representatives shall (1)21 appoint two members from the House of Representatives, one

from the majority party and one from the minority party.

- 1 (2) The President pro tempore of the Senate shall
- 2 appoint two members from the Senate, one from the majority
- 3 party and one from the minority party.
- 4 <u>(3)</u> Two members shall be representatives of universities
- 5 in the State System of Higher Education. [One member]
- 6 (4) Two members shall be from The Pennsylvania State
- 7 University[.], one of whom shall be from Penn State
- 8 Extension.
- 9 (5) One member shall be from the University of
- 10 Pittsburgh. [One member shall be the Director of the
- Northeast Regional Center for Rural Development.]
- 12 <u>(6)</u> The Governor shall appoint two members from among
- the memberships of the following Statewide organizations:
- 14 Pennsylvania Rural Electric Association, Pennsylvania [Grange
- 15 Association] State Grange and the Pennsylvania Farm Bureau.
- 16 <u>(7) One member shall be from the Northern Pennsylvania</u>
- 17 Regional College.
- 18 (8) One member shall be from the Pennsylvania College of
- 19 Technology.

- 21 Section 2. Repeals are as follows:
- 22 (1) The General Assembly declares that the repeal under
- 23 paragraph (2) is necessary to effectuate the addition of
- 24 section 302(a)(7) and (8) of the act.
- 25 (2) Section 311 of the act of April 9, 1929 (P.L.177,
- No.175), known as The Administrative Code of 1929, is
- 27 repealed.
- Section 3. The addition of section 302(a)(7) and (8) of the
- 29 act is a continuation of section 311 of the act of April 9, 1929
- 30 (P.L.177, No.175), known as The Administrative Code of 1929.

- 1 Except as otherwise provided in the addition of section 302(a)
- 2 (7) or (8) of the act, all activities initiated under section
- 3 311 of The Administrative Code of 1929 shall continue and remain
- 4 in full force and effect and may be completed under section
- 5 302(a)(7) or (8) of the act. Orders, regulations, rules and
- 6 decisions which were made under section 311 of The
- 7 Administrative Code of 1929 and in effect on the effective date
- 8 of section 2(2) of this act shall remain in full force and
- 9 effect until revoked, vacated or modified under section 302(a)
- 10 (7) or (8) of the act. Contracts, obligations and collective
- 11 bargaining agreements entered into under section 311 of The
- 12 Administrative Code of 1929 are not affected nor impaired by the
- 13 repeal of section 311 of The Administrative Code of 1929.
- 14 Section 4. This act shall take effect immediately.
